The individual payment instructions so authorised to be issued must be issued and delivered as follows

Choose one of the following dates for deduction:

Commencing on the  15<sup>th</sup> of each month or the  30<sup>th</sup> of each month. In the event that the payment day falls on a Saturday, Sunday or recognized South African public holiday, the payment day will automatically be the previous ordinary business day. Further, if there are insufficient funds in the nominated account to meet the obligation, you are entitled to track my account and re-present the instruction for payment as soon as sufficient funds are available in my account.

I / We understand that the withdrawals hereby authorised will be processed through a computerized system provided by the South African Banks and I also understand that details of each withdrawal will be printed on my bank statement. Each transaction will contain a number, which must be included in the said payment instruction and if provided to you should enable you to identify the Agreement. A payment reference is added to this form before the issuing of any payment instruction. I / We shall not be entitled to any refund of amounts which you have withdrawn while this authority was in force, if such amounts were legally owing to you.

### MANDATE

### CANCELLATION
